TRAINING AND SOCIALIZATION

The Buyer acknowledges the importance of proper training and socialization for the puppy's well-being and agrees to provide appropriate training, socialization, and care.

BREEDING AND SHOW RIGHTS (IF APPLICABLE)

If the puppy is sold with full registration and breeding/show rights, the Buyer agrees to adhere to responsible breeding practices and ethical standards set forth by the breed club and applicable regulations.
